- **Participation at Regional Level** Unique to this year, any member who competed at the Regional Skills Conference is eligible to compete at the State Business Leadership Conference, regardless of whether they placed in their event.
- Involvement with Chapter Project Those who are involved in a chapter project are eligible to attend, even if they didn't compete at the regional skills conference. ### **Virtual SBLC Competitive Events Summary**

### **Eligibility**

Students may participate in two (2) events and one (1) chapter event. Eligibility for competition is as follows:

- **Participation at Regional Level** Unique to this year, any member who competed at the Regional Skills Conference is eligible to compete at the State Business Leadership Conference, regardless of whether they placed in their event.
- Involvement with Chapter Project Those who are involved in a chapter project are eligible to attend, even if they didn't compete at the regional skills conference. Chapter projects include: American Enterprise Project, Champion Chapters, Community Service Project, Partnership with Business, Local Chapter Annual Business Report, Newsletter, Scrapbook, Chapter Website
- Enter an Event Not Offered at Regional Level Some events start at the state level and/or are only offered at the state level. All dues paid members by April 1, 2021 are eligible for these competitions.
- **"Wild Card" participants** Unique to this year, each chapter can have up to ten (10) wild card participants. Wild cards may compete in any individual or team event, even if they did not compete at the regional level. In order to be a wild card participant, competitors must be registered and paid FBLA members by April 1, 2021.

For this year only, there are no maximum limitations on the number of entries a chapter may submit per competitive event, with the exception of Chapter projects. Chapter projects are limited to one (1) entry per chapter.

### **Team Performance in Zoom**

A team competing in any presentation/performance/demonstration event that involves live judging via Zoom may present to the judges in one of the following ways:

- Using separate accounts from separate locations with the Event Administrator moving the competitors as a group
- Using one account with all competitors in the same location FBLA advises using appropriate precautions and following any guidelines and restrictions as set forth by the CDC, your local/state governments, or your specific educational institution.

### **Team Objective Testing**

Where collaborative objective tests are concerned, teams will take test individually and FBLA will average the scores of the team members.

- If a registered team member(s) does not log in and take the test, the scores of only the remaining team member(s) will be averaged
- The team member(s) who did not take the test forfeit their eligibility for the remainder of the event; they will be dropped from the team and will not be allowed to continue in competition





### **Breaking Ties**

Ties will be broken in the following order:

- 1. Judges Determination
- 2. Online Test Result the last 10 questions, followed by time
- 3. Pre-Judged Materials

### Live Competition in Zoom

This year, some events will have elements of LIVE competition. This approach is inspired by the updates that some competitions will be LIVE in Zoom at this year's National Leadership Conference. The official schedule of LIVE competitions will be released according to the schedule provided above.
